ORDINANCE NO. 2013-02

AN ORDINANCE OF THE TOWNSHIP OF NORTH MIDDLETON  
AMENDING AND REVISING CHAPTER 180 OF THE NORTH MIDDLETON  
TOWNSHIP SUBDIVISION AND LAND DEVELOPMENT ORDINANCE  
AND CHAPTER 204 OF THE NORTH MIDDLETON TOWNSHIP ZONING  
ORDINANCE

The Board of Supervisors of North Middleton Township hereby ordains as follows:

Section 1.     Amendment to Subdivision and Land Development Ordinance and Zoning Ordinance

The purpose of this Ordinance is to establish text amendments to the North Middleton Township Subdivision and Land Development Ordinance found in Chapter 180 of the North Middleton Township Code and the North Middleton Township Zoning Ordinance found in Chapter 204 of the North Middleton Township Code. Each has been revised and amended and the full text thereof is attached hereto and made a part hereof by reference as if fully set out at length. No mapping is being changed by this Amendment.

Section 2.     Text of Amendment.

1.     Grammatical and spelling errors have been corrected where necessary.
2.     Minor changes have been made to correct obsolete terms and usages or provide definitions.
3.     Penalty provisions have been revised where necessary to comply with the Pennsylvania Second Class Township Code and Municipalities Planning Code.
4.     General revisions have been made to Ordinances and the text language has been amended to clarify meanings and application of certain Ordinances.

Section 3.     Intent.

The purpose with regard to the amendments to the Subdivision and Land Development and Zoning Ordinance attached hereto acknowledge that the previous Ordinance(s) have been: (1) specifically repealed, or (2) superseded by the Amended Ordinance as set forth in the text attached hereto.

Section 4. Severability.

The provisions of this Ordinance are severable. Should any part of the Ordinance be declared by final court order with jurisdiction to be illegal or otherwise invalid, the balance of the Ordinance shall be unaffected by such declaration.

Section 5. Effective Date.




This Ordinance shall become effective by operation of law pursuant to the Second Class Township Code of the Commonwealth of Pennsylvania.
